

- Focus is on congregate housing
- Enhanced efforts to support providers
- Hired LTC/Hospital leadership team
- Created connection to testing team
- Enhanced partnership between providers and state
- Created protocols to guide efforts

EMERGENCY RENT BRIDGE

- Emergency Rent Assistance available for up to 3 months (if qualified and resources are available)
- Renter is the applicant for assistance.
 - Max 60% of area median income (determined based on most recent 30 days income)
 - Have a valid lease
 - Assets no greater than 3x monthly rent
 - Economic hardship that is COVID-related
- If renter is deemed eligible for ERB, payment will be made directly to housing provider
 - Renter is required to pay 30% of their income toward housing costs
 - ERB will pay the balance due



As of June 1

1,040 applications are pre-qualified and under review

- 22 counties
- Avg monthly rent \$873
- 32% of applicants are single person households
- 14% of applicants have been approved for Unemployment Insurance
- 10% had received an eviction notice at the point of application





Behavioral Health Resources during COVID-19

News about the coronavirus (COVID-19) is everywhere and concern over this virus can result in families feeling anxious. Parents, family members, and other trusted adults play an important role in helping children make sense of what they hear in a way that is honest, accurate, and minimizes anxiety or fear.



EMERGENCY GRANT TO ADDRESS MENTAL AND SUBSTANCE USE DISORDERS DURING COVID-19



April 2020 - August 2021 \$2 million

Increased treatment and recovery services for:

- Individuals with a mental illness and/or substance use disorder
- Healthcare practitioners with a mental illness

CRISIS COUNSELING PROGRAM (CCP)

IMMEDIATE ASSISTANCE PROGRAM (ISP)

Through June 30, 2020 (potential to extend an additional 7 months)

Short-term disaster relief and crisis counseling services





COVID-19 EMERGENCY RESPONSE FOR SUICIDE PREVENTION GRANTS

NORTH DAKOTA SUBMITTED AN APPLICATION 5/22/2020

\$800,000 for 16 months in advancing efforts to prevent suicide and suicide attempts among adults age 25 and older in order to reduce the overall suicide rate.

TELEHEALTH EXPANSION IN FIELD

- Retained core set of staffing at all HSC
- Expanded from 71 to over 350 providers
- Purchased smartphones for clients without access
- Expanded on-site telehealth for walk-in clients
- Expanded Tele-forensic assessment at State Hospital
