

## Title IV, Part A: Use of Funds Quick Reference Guide Student Support and Academic Enrichment



## **Priorities of Title IV Part A**

- access to well-rounded education,
- · improve school conditions for student learning, and
- improve the use of technology to improve the academic achievement and digital literacy of all students.

## **Funding Obligations**

Districts with a Title IV allocation of \$30,000 or more must:

- use at least 20% of Title IV funds on activities to support well-rounded education,
- use at least 20% of Title IV funds on activities to support safe and healthy students,
- a portion of funds on activities to support the effective use of technology, AND of this portion, no more than 15% can be used on technology infrastructure. (See Chart)

Districts with a Title IV allocation of less than \$30,000 may spend funds in all three allowable areas or may choose only one area; however, the 15% cap on technology infrastructure still applies and is calculated using the total amount of funds spent within the technology budget, not the total allocation.

Generally, districts may use funds for a wide variety of activities within each content area, including, but not limited to, direct services for students, professional development for teachers and administrators, salaries of personnel to carry out Title IV identified programs and services. Time and Effort documentation must be kept for all staff paid with federal funds.

<b>700- Property/Equipment</b> for smartboards, projectors, Wi-Fi routers, hotspots, 3D printer, printers, headphones, keyboards, ILA Translators, Laptops, iPads, Document cameras, iPods, ereaders, monitors, etc.	Professional development specific to blended learning, personalized learning, or using educational technology tools in the classroom.
<b>600- Software purchases</b> for blended learning, personalized learning, instructional support, SIS, testing, etc. (e.g., IXL, Schoology, curriculum-specific software, device support software, etc.)	Staff to support integration of educational technology tools and professional development.
<b>800- Site licenses</b> for blended learning, personalized learning, instructional support, SIS, testing, etc.	Funds for substitutes to cover classrooms for attending professional development, observing colleagues, participating in coaching/mentoring, etc. as it relates to Effective Use of Technology.

**Note:** You may purchase technology in Safe and Healthy and Well Rounded, however the technology can only be used for the specific activity in that Title IV, Part A category.
